Description: Due to moisture accumulation over time, both reverse lamps on the subject vehicles can stop working. If this occurs, the driver's view to the rear can be limited when backing during low ambient light conditions, and there may be no indication to others that the vehicle is operating in reverse. This can increase the risk of a crash.

Remedy: The remedy, when available, will involve replacement of both reverse lamp assemblies with improved assemblies, FREE OF CHARGE. Additionally, the wire harnesses will be repaired for any vehicles identified to have corrosion that has extended into the wire harness connector, FREE OF CHARGE. At this time, Toyota estimates the remedy will begin to be available in the 4th quarter of 2025, and we anticipate rolling out this remedy in phases. This remedy will also address other conditions resulting from the moisture intrusion (see FAQ for additional details).

Glossary

CARFAX Well Maintained - Regular Oil Changes

Automobile manufacturers issue recall notices to inform vehicle owners of a safety defect or failure to meet minimum federal safety or emissions standards. Manufacturer recalls are repaired at no cost to the customer.

New Owner Reported

When a vehicle is sold to a new owner, the Title must be transferred to the new owner(s) at a Department of Motor Vehicles.

Ownership History

CARFAX defines an owner as an individual or business that possesses and uses a vehicle. Not all title transactions represent changes in ownership.
